3. The participation fee is €120 per participant, per seminar.
4. The seminars are addressed primarily to the persons registered in the public register («certified persons») for purposes of compliance with paragraph 17(2) of the Directive regarding the certification of persons and the public register ([R.A.D. 174/2015](#)).
5. The seminars will be held in the English language except the seminars on MiFID (on 15 and 22 of October in Nicosia) that will be delivered in Greek.

Due to the restricted number of places (thirty (30) participants per seminar), the applications for participation in the seminars will be served on a first-come, first-served basis.

For registrations before 14:00 the Friday a week before the seminar (8 days ahead) an Early Registration Discount of €20 will be applied.

8. The participation fee must be paid in advance **no later than the Thursday** before each seminar.
