The present Circular is issued pursuant to section 25(1)(c)(ii) & (iii) of the Cyprus Securities and Exchange Commission Law of 2009 (the 'CySEC Law'), as amended.

The Cyprus Securities and Exchange Commission ('the CySEC'), following Circular 748 issued on December 31, 2025, wishes to inform Regulated Entities about the following:
