The Board of the Cyprus Securities and Exchange Commission ('the CySEC') would like to inform the public that, at its meeting held on 24<sup>th</sup> April 2023, decided to impose the following administrative fines for violations of the Transparency Requirements (Transferable Securities Admitted to Trading on a Regulated Market) Law of 2007, as amended ('the Law'), in regard to the publication of the **Half Year Financial Report for the year 2021**:

1. **Aias Investment Public Ltd** (LEI 2138001G526W1KXZU288) – Imposition of a total administrative fine of **€9.500** for violation of sections 10(1) and 37(2)(a) of the Law,
2. **KDM Shipping Public Ltd** – Imposition of a total administrative fine of **€9.500** for violation of sections 10(1) and 37(2)(a) of the Law,
3. **MLK Foods Public Company Ltd** (LEI 259400J93E33KWXTJJ27) – Imposition of a total administrative fine of **€8.500** for violation of sections 10(1) and 37(2)(a) of the Law,
4. **Cyprus Trading Corporation Plc** (LEI 213800BZMPRCWN5C5K92) – Imposition of a total administrative fine of **€7.500** for violation of section 10(1) of the Law,

12. **Agroton Public Ltd** (LEI 259400RHHF7AM6O4YP46) – Imposition of an administrative fine of **€1.000** for violation of section 10(3)(b) of the Law,
13. **Seabird Exploration Plc** (LEI 213800ED88L967PGFK25) – Imposition of an administrative fine of **€1.000** for violation of sections 10(3)(c) and 10(6) of the Law.
