SUBJECT: Seminars regarding CRD4

1. We are in the final stages of transposing the <u>Directive 2013/36/EU</u> on the access to the activity of credit institutions and the prudential supervision of credit institutions and investment firms, for the amendment of the Directive 2002/87/EC and the repealing of the Directives 2006/48/EC and 2006/49/EC and implementing <u>The Regulation 575/2013</u> on prudential requirements for credit institutions and investment firms and the amendment of the Regulation (EU) No. 648/2012 (the "CRD4").

A new Circular will be issued in the coming days informing you accordingly.
