Submission for Q4 2025 (31/12/2025)

The present Circular is issued pursuant to section 25(1)(c)(ii) & (iii) of the Cyprus Securities and Exchange Commission Law ('the CySEC Law').

The Cyprus Securities and Exchange Commission ('the CySEC') wishes to inform Regulated Entities about the following:

### 1. Information Requested by CySEC

- 1.1 A new version of the form, QST-MC Version 24 ('the Form'), found in the <u>Appendix</u>, is issued. The Form must be completed and submitted to CySEC by all Regulated Entities that were authorised or appointed to act as External Managers (in case no authorisation is required by the relevant legislation), by December 31, 2025. In this respect, Regulated Entities that were authorised or appointed to act as External Managers by December 31, 2025, but have not made use of their authorisation must also submit the Form.
- **1.2** The steps that the Regulated Entities will have to follow, for the successful submission of the Form to the TRS, can be found <a href="here">here</a>. Upon submission, the Regulated Entities are responsible to ensure that they have received a **feedback file**, i.e. <a href="mailto:an official submission">an official submission</a> confirmation dispatched by the TRS, in the Outgoing directory.
- 1.3 The feedback file will either contain a NO ERROR indication or, in case that an error(s) has occurred during submission, the description of that error(s). In case of any errors detected during submission of the Form, Regulated Entities must review the Form and

ensure that all errors, are addressed and corrected, before they digitally sign (only applicable for the Excel files) and re-submit the Form. The Form is regarded as being successfully submitted to CySEC, only when a NO ERROR indication feedback file is received.

# 2. Important information when completing the number of Undertaking of Collective Investments (UCIs)

For the purposes of completing the Form, please note that when questions require information about the number of UCIs, the sub-fund(s) of an umbrella fund, should be considered as fund(s). This affects:

- Section A (Question 2, 4.A.2, 4.B.2)
- Section C
- Section G
- Section J
- Section K
- Section L
- Section M

# **Examples:**

- 1) A Regulated Entity has one UCI under management, which has three sub-funds. The answer to question 2.2 (Section A) is <u>three</u>.
- 2) A Regulated Entity has one UCI under management, which does not have sub-funds. The answer to question 2.2 (Section A) is one.
- 3) A Regulated Entity has two UCIs under management, of which one has three sub-funds, and one with no sub-funds. The answer to question 2.2 (Section A) is <u>four</u>.

#### 3. New Validation Check

#### 3.1. Section C

Please note that at the time of submission of the Form, there will be a validation check that will check the following:

- 1. That column E includes the national codes of all sub-funds (or funds in case of single scheme structures) that were under management as of the reference date.
- 2. That column C includes the national codes of all funds that were under management as of the reference date. For single scheme structures, columns C and E should have the same code, and "N/A" will not be accepted.

In view of the above, please note the following:

The below table is an example of a successful entry.

Column C	Column E
LPAIF21	LPAIF21_1
LPAIF21	LPAIF21_2
LPAIF21	LPAIF21 3

The below table is an example of not successful entry, and the file will be rejected.

Column C	Column E	Explanation
LPAIF21/2014	LPAIF21_1	Wrong code in Column C, as it contains the additional element "/2014".
LPAIF 21	LPAIF21_2	Wrong code in Column C, as it includes a space between "LPAIF" and "21".
LPAIF21	LPAIF21	Wrong code in Column E, as the fund is an umbrella structure, and therefore the sub-fund code should be reflected.
LPAIF21	N/A	As per the above. Please note that "N/A" will not be accepted.

• If a fund/sub-fund was authorized or registered before the reference date, it must be included in Section C, regardless of whether it has raised capital.

#### 4. Deadline for the submission of the Form

- **4.1.** The Form must be successfully submitted electronically, via CySEC's Transaction Reporting System ('TRS') by Friday, January 30, 2026, the latest.
- **4.2.** CySEC wishes to emphasise the importance of meeting the deadline set, for the successful submission of the Form.
- 4.3. Failure to promptly and duly comply with the above, may bear the administrative penalties of section 37(5) of the CySEC Law. It is further noted that CySEC will <u>not</u> send any reminders to those who fail to promptly and duly comply.

### 5. General Comments for the Form

- **5.1.** The Form will be available **only** in the **English language.**
- **5.2.** Reporting entities are required to report data in **Euro**, rounded to the nearest unit.
- **5.3.** Please always ensure that you have the latest version of the Form, i.e. **Version 24**.
- **5.4.** Instructions on the completion of the Form can be found in the 'instructions' worksheet of the Form.
- 5.5. Before submitting the Form, please ensure that all validation tests that are contained in the Form (Sections A, B, C, D, E, F1, F2, F3, F4, G, H, I, J, K, L, M and Validation Tests Worksheet) are TRUE (Green Colour).

## 6. Method of creating, signing and submitting the Form to CySEC

After populating the required Excel fields of the Form, the Regulated Entities should name their Excel file in accordance to the following naming convention:

# The information below explains the naming convention:

- (1) Username is the username of the TRS credentials, which should already be in the possession of the Regulated Entities that have previously submitted any electronic file to the TRS system. This codification should be entered in capital letters. Regulated Entities, that have not previously requested the TRS credentials, can do so by referring <a href="here">here</a>, where further information is provided about the TRS.
- (2) **yyyymmdd** this denotes the end of the reporting period of the Form. In this case the Form should have a 20251231 format. Future Forms will have different reporting periods.
- (3) **QST-MC** this is the coding of the Form, that remains unchanged and should be inserted exactly as it appears.
- (4) The Excel® must be of 2007 version and onwards. Excel will add the extension .xlsx as soon as it is saved. This extension should not, under any circumstances, be inserted manually.

# 7. Support

## 7.1. Queries on how to complete the fields of the Form

### 7.2. Technical Queries on digitally signing and submitting the Form
