3. The participation fee is €120 per participant, per seminar.
4. The seminars are addressed to the persons registered in the public register («certified persons») for purposes of compliance with paragraph 16(2)(a) of the Directive regarding the certification of persons and the public register ([R.A.D. 499/2012](#)).
5. Priority will be given to the certified persons but in case there is availability of places participation requests from other interested persons will be accepted.
6. The seminars will be held in the English language.

Due to the restricted number of places (thirty (30) participants per seminar), the applications for participation in the seminars will be served on a first-come, first-served basis.

The registration forms must be submitted **no later than the Tuesday**, week before each seminar. For registrations after Tuesday, a late registration fee of 30% (€36) will be charged.

8. All participants will be informed about the date of the seminar they will attend and the details of the payment of the participation fee, via electronic mail.
9. The participation fee must be paid in advance **no later than the Wednesday** before each seminar.
