subsidy. The participation cost is two hundred Euros ( $\in$ 200) per participant (the payment fee is  $\in$ 122 in case of subsidy).

All the participants of the programs (\*) that satisfy the HRDA's criteria, should complete Form 7 of the HRDA (related instructions are included in Form 10 of the HRDA's) and send it to the Commission at least one week before the commencement of the seminars.

- 3. The participation cost for the seminar that will be held in Limassol, which has not been approved by HRDA is one hundred twenty-two Euro €122.

- 5. The seminars will be held in the English language.
