Following a previous <u>Announcement</u> dated 30<sup>th</sup> June 2020, the Board of the Cyprus Securities and Exchange Commission ('CySEC') would like to inform the public that, at its meeting held on 16<sup>th</sup> July 2020, has revised the level of the administrative fine imposed on **CPI Holdings Public Ltd** and decided the imposition of **an administrative fine of €1.875** for the violation of section 9(1) of the Transparency Requirements (Transferable Securities Admitted to Trading on a Regulated Market) Law of 2007, as amended.
