

## **ANNOUNCEMENT**

According to the <u>Directive</u> of the Cyprus Securities and Exchange Commission ("the Commission") regarding the Certification of persons and the public register («the Directive»), the Commission prepares and makes public on its website a Table of the Successful Candidates. ## Registration of Successful Candidates in the Public Register

The persons listed in the above Table of Successful Candidates and who will be registered in the Public Register for the <u>first time</u>, must complete the attached <u>Registration Form</u>. The Registration Form must be sent, in excel form, via email, to the electronic address: certifications@cysec.gov.cy.

## Annual renewal of the Registration in the Public Register

In accordance with Paragraphs 16(1) and 16(2) of the Directive:

- "(1) Persons registered in the public register shall be obliged to renew their registration in the public register within two months from the end of each calendar year **that follows their registration** in the public register.
- (2) Persons registered in the public register shall be deemed to have renewed their registration when they:
- (a) submit to the Commission a statement of continued professional training on topics that fall within the existing legislation on the capital market, of a duration of five (5) hours for persons registered in the public register for the basic examination and of a duration of ten (10) hours for persons registered in the public register for the advanced examination, for each calendar year.
- (b) pay to the Commission an annual renewal fee of eighty euro (€80)."

Following the above, the persons registered in the public register for <u>the first time</u>, in 2014, are obliged to renew their registration in the public register, within two months from the end of 2015 (by the end of February 2016), by completing during 2015 the Continuous Professional Training ("CPT"), as provided for in paragraph 16(2)(a) of the

Directive and by paying the annual renewal fee of €80, as provided for in paragraph 16(2)(b) of the Directive.

The persons already registered in the public register under the Basic Examination, who have succeeded in the Advanced Examination during 2014, must renew their registration in the public register, by February 2015, in accordance with the Directive, by paying the renewal fee of €80 and by completing 5 hours of CPD during 2014. The CPT will have to be increased to 10 hours during 2015.
