The Board of the Cyprus Securities and Exchange Commission ('the CySEC') would like to inform the public that, at its meeting held on 13th October 2025, decided to impose the following administrative fines for violations of the Transparency Requirements (Securities Admitted to Trading on a Regulated Market) Law of 2007, as amended ('the Law'), in regard to the publication of the **Half Year Financial Report for the year 2024**:

1. **KDM Shipping Public Limited** – Imposition of a total administrative fine of **€9.500** for violation of sections 10(1) and 37(2)(a) of the Law,
2. **Toxotis Investments Public Ltd** (LEI 213800P79CY54Q648G91) – Imposition of a total administrative fine of **€9.000** for violation of sections 10(1) and 37(2)(a) of the Law,
3. **A. Tsokkos Hotels Public Limited** (LEI 213800ES6DQXPPS7ED10) – Imposition of an administrative fine of **€5.000** for violation of section 10(1) of the Law,
4. **Dome Investments Public Company Limited** (LEI 2138003L26CJA8XIDU69) – Imposition of an administrative fine of **€5.000** for violation of section 10(1) of the Law,
5. **MLK Foods Public Company Ltd** (LEI 259400J93E33KWXTJJ27) – Imposition of a total administrative fine of **€4.750** for violation of sections 10(1) and 37(2)(a) of the Law,
6. **Karyes Investment Public Company Ltd** (LEI 254900VLUGAZ573WQ398) – Imposition of an administrative fine of **€2.250** for violation of section 10(1) of the Law,
7. **Unifast Finance & Investments Public Company Limited** (LEI 2138002KM88NRCDWN269) – Imposition of an administrative fine of **€1.750** for violation of section 10(1) of the Law,
8. **Agroton Public Limited** (LEI 259400RHHF7AM6O4YP46) – Imposition of an administrative fine of **€1.000** for violation of section 10(3)(b) of the Law,
