## ORGANISER

### CySEC

The Cyprus Securities and Exchange Commission (CySEC) is the independent public supervisory Authority responsible for the supervision of the investment services market, transactions in transferable securities carried in and out of the Republic of Cyprus and the collective investment and asset management sector. It also supervises the firms offering administrative services which do not fall under the supervision of The Institute of Certified Public Accountants of Cyprus (ICPAC) and the Cyprus Bar Association. The CySEC was established in accordance with section 5 of the Securities and Exchange Commission (Establishment and Responsibilities) Law of 2001 as a public legal entity. The operation of the CySEC is governed by the Laws regulating the Structure, Responsibilities, Powers, Organization of the Cyprus Securities and Exchange Commission and Other Related Matters (N73(I)/2009).

## COORDINATOR

### IMH

IMH is the largest business knowledge and information transfer organization in Cyprus. Its services include the coordination and running of conferences, seminars and commercial exhibitions, business media publishing and human resources consulting. ## FEATURED SPEAKERS BIOGRAPHIES

### H.E. NICOS ANASTASIADES, PRESIDENT OF THE REPUBLIC OF CYPRUS

Nicos Anastasiades studied Law at the University of Athens and pursued his postgraduate degree in Maritime Law at the University of London. Nicos Anastasiades is a founding member of the Youth of the Democratic Rally (NEDISY), in which he served from the posts of District Secretary, Vice President and President.

After his successful term in NEDISY he took action next to the party's historical leader Glafkos Clerides from the positions of First Vice President and later Deputy President until 1997. He is a member of the Cyprus National Council since 1995. Nicos Anastasiades was triumphantly elected as President of the Democratic Rally in 1997, a position that the members and officials of the party firmly trusted him with by being re-elected in 1999, 2003, 2007 and 2012.

At the same time Nicos Anastasiades was being elected Member of the House of Representatives from 1981 until his election to the Presidency of the Republic. He has also been elected Vice President of the House of Representatives for the years 1996-2001 and he has served as Parliamentary Spokesman of the Democratic Rally. From his position as Chairman of the Committee on Foreign Affairs, as Head of the Inter-Parliamentary Committee on Foreign Affairs as well as Head of the Cyprus delegation to the Inter-Parliamentary Union (IPU), he represented the Cyprus Parliament since 1991 and took part in a number of international missions, specialized conferences and visits.

Since his election to the Presidency of the Democratic Rally he also participated in all European People's Party (EPP) Summits and Conferences, represented the Democratic Rally in the European Democrat Union (EDU) and actively participated in all conferences of the International Democrat Union (IDU). Nicos Anastasiades was first elected President of the Republic of Cyprus on February 24, 2013, and re-elected in 2017.

## DEMETRA KALOGEROU, CHAIRWOMAN OF THE CYPRUS SECURITIES AND EXCHANGE COMMISSION

Demetra Kalogerou (BSc, MSc, MPhil) is the Chairwoman of the Securities and Exchange Commission since September 2011, the independent public supervisory Authority responsible for the supervision of the investment services market, transactions in transferable securities carried out in the Republic of Cyprus and the collective investment and asset management sector. It also supervises the firms offering administrative services which do not fall under the supervision of ICPAC and the Cyprus Bar Association. The vision of the CySEC is to establish the Cyprus securities market as one of the safest, most reliable and attractive destinations for investment, and its mission is to exercise effective supervision to ensure investor protection and the healthy development of the securities market.

Also, as of November 2012, Demetra Kalogerou is a member of the Cyprus Public Audit Oversight Board, which has been established for the oversight of auditors and audit firms. Furthermore, from September of 2013 until June of 2014, Demetra Kalogerou had been a member of the Resolution Authority, along with the Minister of Finance and the Governor of Central Bank of Cyprus, which supervised the implementation of the resolution of financial institutions in Cyprus.

Demetra Kalogerou previously held the position of a Senior Officer of the Cyprus Stock Exchange and, overall, she has more than 15 years' experience in the financial sector. Her duties as a Senior Officer at the CSE included the supervision of transactions in transferable securities and various CSE markets, the monitoring of compliance of listed public companies with their continuous obligations, the research and development of new products, as well as the promotion of financial markets.

As a result of the above responsibilities and mainly of her prominent role in the leadership of the Cyprus Securities and Exchange Commission, Demetra Kalogerou developed an in-depth knowledge on all aspects of the securities market and acquired extensive experience in matters relating to the smooth and orderly development of securities markets and investor's protection.



## KEYNOTE SPEAKER

### STEVEN MAIJOOR, CHAIR OF THE EUROPEAN SECURITIES AND MARKETS AUTHORITY

Steven Maijoor has been the Chair of the European Securities and Markets Authority (ESMA) since taking up office on April 1, 2011. He is the first chair of the authority and is currently serving his second five-year term. He is responsible for representing the Authority as well as chairing ESMA's Board of Supervisors and the Management Board. The role of the Board of Supervisors is to give strategic guidance to ESMA and make all main regulatory and supervisory decisions. The Management Board's purpose is to ensure that the Authority carries out its mission and performs its tasks.

Prior to taking up this role, Steven Maijoor was Managing Director at the AFM, the Dutch financial markets regulator, where he was responsible for capital market supervision, including financial reporting and auditing, prospectuses, public offerings, and the supervision of the integrity of financial markets. During his term, the scope of activities of the AFM vastly expanded and he was responsible for building and implementing supervision in the capital market area. In his regulatory role at the AFM, Steven Maijoor has held a number of international positions, including the Chairmanship of IFIAR (International Forum of Independent Audit Regulators).

Before joining the regulatory world, Steven Maijoor was the Dean of the School of Business and Economics at Maastricht University, and had pursued a long career in academia which included a variety of positions at Maastricht University and the University of Southern California.

Steven Maijoor holds a PhD in Business Economics from Maastricht University, was a research student at the London School of Economics, and has a master in Business Economics from the University of Groningen.

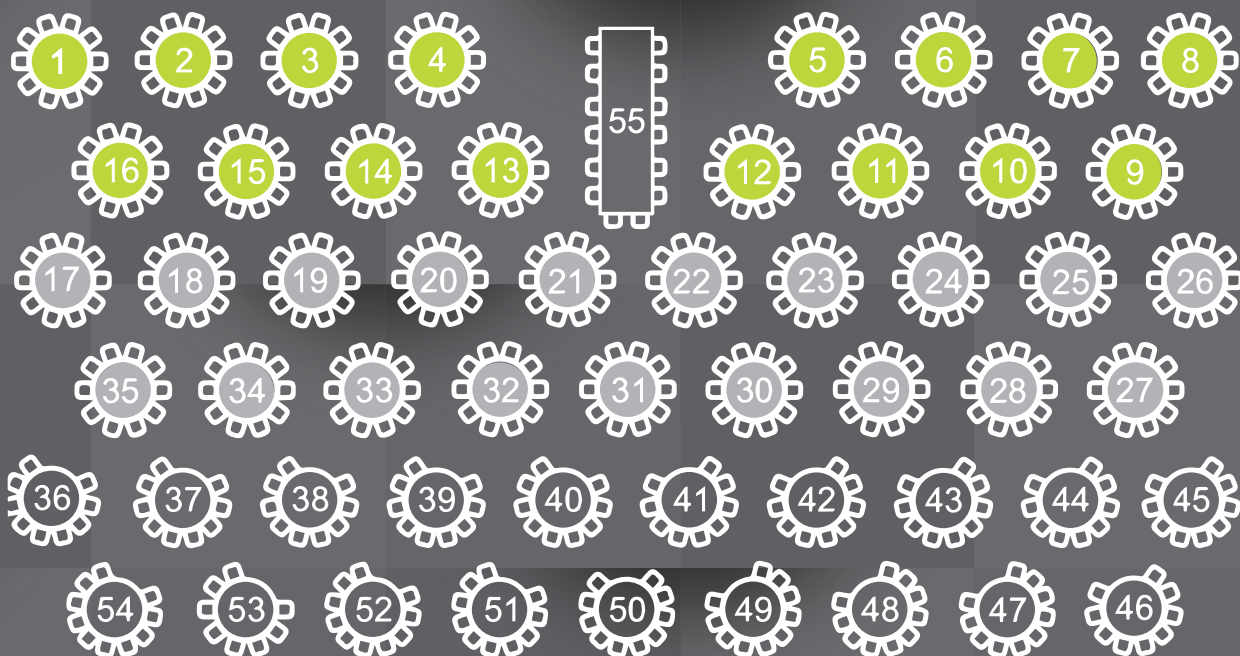
