The Board of the Cyprus Securities and Exchange Commission ('the CySEC') would like to inform the public that, at its meeting held on 14th of July 2025, decided to impose the following administrative fines for violations of the Transparency Requirements (Securities Admitted to Trading on a Regulated Market) Law of 2007, as amended ('the Law'), in regard to the publication of the **Annual Financial Report for the year 2023**:

1. **KDM Shipping Public Ltd** – Imposition of a total administrative fine of **€17.000** for violation of sections 9(1) and 37(2)(a) of the Law,
2. **Toxotis Investments Public Ltd** (LEI 213800P79CY54Q648G91) – Imposition of a total administrative fine of **€16.500** for violation of sections 9(1) and 37(2)(a) of the Law,
3. **Dome Investments Public Company Limited** (LEI 2138003L26CJA8XIDU69) – Imposition of an administrative fine of **€13.500** for violation of section 9(1) the Law,
4. **A. Tsokkos Hotels Public Limited** (LEI 213800ES6DQXPPS7ED10) – Imposition of an administrative fine of **€13.500** for violation of section 9(1) the Law,
